**-AND ATTACH THE SUBMITTAL FORM TO THE BACK OF EVERYPIECE YOU ARE SUBMITTING. THERE HAVE BEEN TO MANY TIMES I CAN'T READ WRITING AND CAN NOT READ INFO, OR THERE IS NO INFO THERE.**

IMPORTANT – Read This to Avoid Problems With Your Submission

- Each artist is allowed up to five (5) pieces. Contact [jbrown@thegoodfoot.com](mailto:jbrown@thegoodfoot.com) with a pic for approval of multiple piece records.
- Make sure your records are legibly labeled on back and that the labels match up to your submission forms.
- Allow at least 48 hours drying time before packing and shipping your records. Also wrap them in plastic or other film, DO NOT USE PAPER.

**Entry Fee**

Great news no entry fee's this year. Please help us keep this possible, by filling out all forms, and getting us work on deadlines.

**Websales**

We will be doing online sales now during the show, so it I will need pictures of every record you will have in the show. Please email to me or bring

when you drop off work or send in work. Make sure the images represent the art well, crop, color correct, ect ..

-web ready jpg 800 pixels on the longest side

## **SALES**

If you would like to sell your piece(s) and receive payment please provide a Paypal ID (preferred method) or the name your check should be made payable to. There is a 30% commission on any gallery sales. The artist's payments will be sent out 30 days following the closing with preference given to those with Paypal accounts since they are the easiest. Please make sure your payment information is legible. Last year some payments were delayed because Jason could not read their handwriting.

## **Donations**

Vinyl Killers remains a grassroots show and receives **NO** corporate funding or sponsorship in spite of getting numerous offers. The sales commissions do not even come close to justifying the time spent coordinating and promoting the shows year round. Everyone involved in VK does it purely out of love for the show.

If you have benefited from VK's efforts and/or are down with what we are doing then please consider donating the proceeds from one of your records sale to Vinyl Killers. Your donation will go directly back into keeping everything afloat and promoting VK for more exposure.

## **AFTER THE SHOW**

You have two options:

1. You can have any unsold pieces remain on Goodfoot online store. With the past show's the online store has sold as well as the shows and the site gets a TON of traffic following the shows. However, taking the photographs, building the store inventory, packaging, and shipping all require much more time and expense than the show, so web sales will be at a 40% commission. This is not a scam to cash in and I hope everything sells at the show.

Also, ***please be aware that if your piece does not sell within one year from the show closing it becomes property of Vinyl Killers.***

2. If you would like your artwork returned to you, please include a self-addressed, stamped envelope (SASE) **with the correct amount of return postage included**. This means the same size as the original package. Once the show comes down any unsold work will be mailed back in your SASE envelope.
